


Performance since launch to 30 June 2023*










Sector Breakdown

Commentary

Emerging markets underperformed developed markets in June as US equities continued to benefit from positive news flow in the technology sector. However, emerging market portfolios saw \$22bn of foreign net inflows on the back of encouraging inflation data, expectations that the Fed's rate hiking cycle was coming to an end, a weakening US dollar and excitement about the potential of artificial intelligence. The MSCI EM Mid Cap Net TR Index returned 1.2% in GBP terms over the period, while the broader MSCI EM Index gained 0.6%.

MMIT had a strong month, with its net asset value (NAV) per share and share price increasing by 3.7% and 3.6% respectively. The trust traded at a premium for much of the period and continued to issues shares to meet investor demand. The strongest contributors were South Korean medical device maker Classys (+1.2%) and semiconductor testing company LEENO Industrial (+0.7%), followed by Indian branded steel pipe maker APL Apollo (+0.6%). The main detractors were software companies EPAM Systems (-0.9%) and Persistent Systems (-0.3%) and Taiwanese sensor technology company ZillTek (-0.2%).

Recent research trips have resulted in new additions to the portfolio, targeting the domestic travel industry in India and the booming IT sector in Southeast Asia.
