

Performance since launch to 31 January 2023*





Commentary

After a turbulent 2022, global equity markets were off to a strong start in the new year. With inflation moderating investors now expect the Federal Reserve to slow its pace of interest rate hikes. The reopening in China changed the outlook (and investor sentiment) not only for Asia but for the global economy. Recession fears took a back seat and the IMF in its January Outlook revised global growth for 2023 upwards by 0.2% to 2.9%, with emerging Asia growing the strongest (5.3%).

In January emerging markets (equities and debt) saw the largest monthly inflows in two years. During the reporting period, Mobius Investment Trust's net asset value and share price increased by 5.9% and 4.3% respectively, trading at a narrow average discount of 0.01%.

The strongest contributors to January performance were MMIT's Asian holdings, with Hong Kong-based health care chain EC Healthcare contributing 1.3%, followed by Indian software company Persistent Systems (+1.1%) and eMemory Technology (+1.0%) from Taiwan. Software company Logo (-0.6%) and clothing retailer Mavi (-0.5%) from Turkey were the main detractors.
