

Investor Profile

Mobius Investment Trust plc has no required minimum holding period and is designed for long-term investment (at least five years). It is intended for both institutional and professional investors. MMIT invests in equities and it may therefore be subject to volatility. This requires an elevated risk tolerance and capacity.

Commentary

The Net Asset Value (NAV) of the Mobius Investment Trust (The Company) increased by 3.9% in June 2019, closing at 97.8p. The share price increased by 5.5% over the same period, with MMIT trading at a 2.4% premium on 30 June. Over the course of the month, there was an average premium to NAV of 1.6%.

As of 30 June 2019, the Company had allocated 80.6% of capital, with 21 holdings across 10 countries. As noted in May's factsheet, the increased cash position is attributable to three disposals over the last few months (please see Q2 2019 MMIT Manager Commentary for further details). In June, we exited our position in Oriflame Cosmetics following the announced takeover tender offer. MMIT's target cash level is around 5%, and current funds will be utilised to increase exposure to the highest conviction portfolio ideas and in the pipeline of new companies competing for entry into the portfolio. We have initiated two new positions in India and China, although are restricted from providing further details until we reach the target weight.

The MSCI Emerging Markets Index (GBP) was up 5.3% over June 2019, while the MSCI Frontier Markets Index (GBP) was up 1.2%.

In June, MMIT issued 1.1 million new shares as part of the ongoing tap issuance. Up to 18 July, 25.0% of the tap (5.0 million new shares) have been issued.
